## 77th Annual Meeting 1962

The seventy-seventh annual meeting opened at Shilo, Manitoba, at 9:00 a.m., Friday 5th October 1962, with the President, Col. E. W. Cormack, OBE, ED, CD, in the chair.

## 1. President's Report

It is my pleasure and privilege to welcome you here today. Your Association has had a very busy year indeed. Some of our activities I propose to touch upon — much of the detail of the work done will become evident to you as the chairmen of the various busy committees present their reports.

Due to the fact that our very distinguished and welcome visitor, the Master Gunner, was a guest at your President's home base on Wednesday evening, the executive meeting planned for Thursday morning had to be postponed. However, this body has now met, discussed matters of current interest and importance, and brings a number of recommendations to your attention.

Last January there assembled at Ottawa representatives from all Corps Associations, together with those from the Royal Canadian Navy and the Royal Canadian Air Force. The purpose of this annual conference is to consider seriously the various resolutions passed at each Corps Association annual meeting and to agree, if possible, on representations to the proper authorities with a united voice.

In practice, many resolutions passed some months ago have already been attended to by the Chief of the General Staff, Director of Military Training, or others competent to deal with them. Thus the few remaining have to be scrutinized with care before presentation or withdrawal. It is my observation that these conferences are taken seriously by all concerned – the delegates from the Associations, Military Advisors or Directors of the respective Corps, the Director of Military Training, Chief of the General Staff and the Minister of National Defence himself.

During this meeting you will be asked to consider a number of resolutions. As you are aware these should be submitted before-hand on a pro forma, so that all may study them. However, in addition to the four subjects you will find in Appendix B, every endeavour will be made to allow you an opportunity for discussion of other pertinent or urgent matters, if you so desire.

In case the opportunity does not occur again, I would like to seize this chance to say a word of appreciation for the tremendous, indeed dedicated, services on your behalf rendered by our Honorary Colonel Commandant. For the last five years Brigadier Todd has rendered yeoman service to the cause of the Gunners. Another member of this happy team is Colonel Geoff Brooks, the Director of Artillery. Geoff is the Gunner's Gunner – the stimulation he has given to the Royal Regiment of Canadian Artillery, the inspiration to carry on with pride in the highest traditions of the past is something we associated with him have been privileged to observe.

Another of this team is Lt. Col. Ted Scott, our new Secretary-Treasurer. After the long term of service rendered on our behalf by Brigadier Dick Leach, Ted found himself facing quite a challenge. He has been indefatigable in working for the interests and betterment of our Association.

To each of these gentlemen, I thus express my thanks. They have kept my nose to the grindstone – no mean task, and the rest of the executive working in their various roles have also performed with efficiency and devotion.

## 4. Report of History Committee

Brigadier H. T. Airey, chairman of the History Committee presented the following report which was adopted by the meeting.

In October 1961, your committee made verbal arrangements with Professor R. A. Spencer (Dept. of History, University of Toronto) to write the History of the Royal Canadian Artillery. We understood draft chapters were to be ready for circulation to the committee beginning in the Spring of 1962. After several verbal enquiries during the Spring of this year, as to progress, or, rather, apparent lack of progress, a letter was sent to Professor Spencer in mid June expressing our concern that no draft chapters had been received. Professor Spencer resented this implied lack of confidence on the part of the committee and immediately tendered his resignation. The committee, after consultation, agreed to accept Professor Spencer's resignation, the chairman having tried to persuade Professor Spencer to withdraw it prior to submission to the committee.

After considering several other possible authors, your committee approached Col. G. W. L. Nicholson, former D. History at A.H.Q. and discussed the project fully with him on September 14th. Col. Nicholson submitted a proposal for the writing of the History, which your committee has seen fit to accept.

Col. Nicholson plans on submitting draft chapters about April 1964, completing this phase before the end of 1965, with publication in the Fall of 1966. It is expected that a research assistant will be made available to Col. Nicholson. The cost of preparation of the History will be about \$10,000. with Col. Nicholson's fee accounting for three-quarters of this sum. Publication costs will be about ten to twelve thousand dollars less amount recovered by sales of the book.

#### 5. Report of Competitions Committee

This was presented by Lt. Col. J. G. Lefebvre, chairman of the committee and was adopted. This report read:

The Competition Committee was appointed by the President, its members being

A meeting was held at Shilo Camp on Friday, October 5th, 1962. The Committee studied the following points with a view to preparation of a plan for competitions amongst Militia Units and award of prizes:-

- 1. Type of competitions and how they could be held.
- 2. The events for which existing trophies could be awarded.
- 3. Allocations of funds for the cost of competitions and prizes to be taken from the \$5,000.00 set aside by the Association.

The Committee agreed that, initially, a competition programme, such as Gun Drill, be communicated to all Militia Group Commanders. The proposed competition, noted below, is to be forwarded to Group Commanders by the Secretary RCAA, with a view to having a reply by 16 December 1962.

The Committee further agreed that competitions be held on an Area Command basis, one detachment per unit. It was suggested that the Director for Artillery be requested to advise on the evaluation of competitive test and how it could best be carried out so as to achieve a common standard.

It was finally agreed that all Commanding Officers of Militia Artillery Units be asked, through Secretary RCAA, to submit their suggestions for other types of Artillery Competitions, including firing contests.

The Committee recommended the following resolutions:

1. To allocate up to a maximum of \$25.00 per trophy for their reconditioning.

2. To award \$25.00 in prize money to each winner of a trophy.

It is estimated that, initially, 20 trophies approximately would be required for all Area Commands.

The above report was forwarded to all units but only one reply was received.

The Director of Artillery has been requested to obtain from the Director of Militia and Cadets particulars of competitions held by other Corps.

## 6. Report of the Canadian Gunner Committee

The chairman, Brig. J. A. Pringle, presented his report, which follows, which was approved by the general meeting.

At the 1961 meeting it was reported that The Canadian Gunner would no doubt have to cease publication early in 1962. It was with regret of all concerned that this decision had to be made, the following three factors making this decision mandatory.

- 1. The cost of publication was increasing.
- 2. Subscriptions had dropped. The high point for Militia subscriptions was in 1956 and by 1961 the number had dropped to 300. To reach a break even point it was necessary to have something in the

order of 2000 subscriptions from the Militia in addition to local subscribers.

3. Advertising revenue is related to paid subscriptions and this source of revenue was inadequate to meet costs.

The deficits had been met by contributions from the RCA Regular Fund of \$4000. and the RCA Regular Regimental Funds of \$1400. and it was impossible for these funds to continue to meet the deficit.

Col. Brooks and Col. Leslie and the School should be commended for their efforts to continue publication in the face of the many problems encountered and it was with regret on their part that the decision to discontinue publication had to be made.

## 7. Chairs for Shilo Mess Commmittee Report

Brigadier J. A. Pringle presented his report, which was adopted. The report is as follows:

At the 1960 meeting an appeal was made to artillery units and members of the Association for assistance in furnishing the home mess of the Regiment. It was suggested that assistance be given in the way of donations for chairs. These chairs would be used as a means to commemorate either existing or former regiments or batteries. The cost of each chair would be \$90 and a plaque would be attached to each chair showing the unit. In addition a book with a page for each chair would be established, giving a short history of the unit being commemorated. The book is to be placed in the mess.

At the 1961 meeting a committee was formed to try and further this cause, the members of the committee being Brig. J. A. Pringle, Brig. G. B. Robertson, Lt. Col. B. Tedman and Lt. Col. W. D. Jackson.

At this meeting the following donations of chairs have been made, 17 Fd Regt., 37 Fd. Bty. 17 Regt.; 60 Bty. 17 Regt.; 76 Bty. 17 Regt.; 46 Fd. Regt.; 57 LAA Regt. The following pledges were made, 40 Med. Regt., 44 Fd. Regt., 50 Fd. Regt., 18 Fd. Regt., 62 LAA Regt.

#### **Resolution to the Chief of the General Staff** 8. No. 1/62—Artillery Summer Camps

WHEREAS Artillery Militia units have now obtained a reasonable standard of National Survival Training, and

WHEREAS a significant proportion of training time is again being devoted to Corps subjects, and

WHEREAS the present Militia Summer Camps do not have adequate facilities for Artillery training in deployment and have no facilities for range practice,

Now Therefore Be It Resolved

7 Fd Arty Regt RCA (M) 21 Fd Arty Regt RCA (M) 50 Fd Arty Regt RCA (M) 40 Med Regt RCA (M) 46 Fd Regt RCA (M) 30 Fd Regt RCA (M) HQ Cdn Arty, 2 Cdn Corps 11 Fd Arty Regt RCA (M)

That Artillery Militia Units attend a corps camp at least every other year and that such corps camps have adequate training facilities for deployments and firing practice.

The Chief of the General Staff replied as follows:

It is too early to determine the correct ratio of time to be given to military vis-a-vis survival training, however, in the interim the following policy will apply:

- a. There is no objection to conducting some military training at summer camps after requirements for national survival training have been met.
- b. Where it is not feasible to fire corps weapons at camps, every two or three years, at the discretion of General Officers Commanding commands, units may be concentrated at the nearest location to fire weapons and practice special to corps skills provided it is done within command resources of manpower, equipment and funds.
- c. All corps cannot be concentrated in the same year nor will large concentrations organized on a command or regional basis be authorized.

## 9. Resolutions to Director of Artillery

## No. 2/62—Qualification of Captain Artillery

WHEREAS the present qualifications for the rank of captain require no corps training, and

WHEREAS the present requirements are three consecutive summer camps plus 75% LHQ training,

Now Therefore Be It Resolved

That the Royal Canadian Artillery Association appoint a Committee to investigate and recommend to the Director of Artillery a format for a corps examination which would be a prerequisite to qualification for the rank of captain artillery. This examination to be such that each artillery regiment be capable of conducting same from its own resources, i.e., reinstitution of a form of corps examination to replace the present three consecutive summer camps and LHQ training.

The President appointed Lt. Col. H. T. Vergette, CD and Lt. Col. E. C. Scott, ED to discuss this matter with the Director of Artillery. The problem was taken up with the Director of Militia and Cadets who informed the Director of Artillery that this is a problem with all corps. It is at present being studied for all corps of the Army and we will be advised of the conclusions reached at a later date.

## No. 3/62—Seniority of Regiments

The original resolution put forward was

WHEREAS it is an established fact that there is no such thing as seniority of regiments in the Royal Regiment of Canadian Artillery, and

WHEREAS it is also an established practice that Field Regiments precede Medium Regiments on combined parades, and

WHEREAS frequently there is more than one regiment of the same branch on a parade,

Now Therefore Be It Resolved

That this Association approve that on parades involving more than one regiment of artillery, that the order of march be Field Regiments, Medium Regiments and that the regiment with the lower number precede regiments with higher numbers within its branch.

A spirited debate ensued regarding this resolution, which was finally withdrawn and the following substituted.

Now Therefore Be It Resolved

That this Association request and recommend to the Director of Artillery that an order of precedence be established for all artillery units.

The Adjutant General commented that whatever the Director of Artillery recommended he would approve.

The answer to this resolution has been printed in Standing Orders and paragraphs 133-140 inclusive are reprinted hereunder.

#### Precedence

133. The following is the order of precedence of the Canadian Army:

Cadets of the Canadian Services Colleges

The Royal Canadian Horse Artillery

The Royal Canadian Armoured Corps

The Royal Canadian Artillery (except the RCHA)

Remainder of list may be found in CAO 220-3.

134. Regiments and batteries of the Canadian Army (Militia) take precedence after all units of the Canadian Army (Regular).

135. Regiments and units take seniority within the Royal Regiment of Canadian Artillery according to the date of their embodiment in the Canadian Army (*Regular*) or (Militia).

136. The seniority of units within the Royal Regiment of Canadian Artillery (Regular) is:

#### **Precedence on Parade**

137. The order of precedence of units on parade is, in general, headquarters, field branch artillery, air defence artillery.

138. In each branch the following principles govern precedence on parade: a. Field Branch Artillery

(1) Royal Canadian Horse Artillery Regiments.

(2) Field Artillery Regiments.

(3) Medium Artillery Regiments.

(4) Surface to Surface Missile Units.

- (5) Locating Units.
- (6) Air Observation Post Units.

## b. Air Defence Artillery

- 139. The following additional principles apply to both branches:
- a. Within each section units take precedence in order of their numerical/ alphabetical designation, eg, 1 RCHA, 6 Fd Regt, 7 Fd Regt/A Bty, B Bty.
- b. When detached batteries from regiments, or independent batteries or troops, are on parade with complete regiments, the larger formation has precedence over the smaller.
- c. If detached batteries are on parade away from their regiment they will take precedence according to their regiment's number, below regiments with RHQ on parade but above any independent batteries.

140. When units are on parade with their guns and/or equipment, the precedence on parade may be varied at the discretion of the Commander.

## 10. Resolutions to the Conference of Defence Associations No. 4/62—Junior Officers Qualifications

WHEREAS the most effective method of securing suitable junior Militia Officers with the desirable educational background is direct recruitment of students while still attending university or other institutions of higher learning, and

WHEREAS the necessity of summer employment forces such students interested in military training to join the University Contingent COTC, rather than through regular Militia Units not able to provide full summer training, and

WHEREAS the past and present experience of most Militia Units in securing University Contingent COTC graduates has been disappointing, and the numbers negligible,

Now Therefore Be It Resolved

That a system of officer qualification be re-established similar to the former Method D, whereby officer training is given on a unit basis during the winter training season, followed by attachment to Corps Schools and other Regular Army establishments during summer months, permitting much more thorough and comprehensive officer training than at present available.

There followed a lively discussion in which the Adjutant General participated. It was agreed that the above resolution be submitted to the Conference as it applied generally to the qualification of junior officers.

At the Conference this Resolution was combined with one submitted by the Royal Canadian Army Service Corps Association. See Report of Conference of Defence Associations. Resolution No. 3/63.

### No. 5/62—Administration of Militia Units

Now Therefore Be It Resolved

That in order to maintain and/or increase the efficiency of Militia Units, sufficient A and Q help be allowed such units in the form of one "A" Non Commissioned Officer and one "Q" Non Commissioned Officer or one A and Q Officer supported by a senior Non-Commissioned Officer.

This resolution was combined with one submitted by another corps. See Report of Conference of Defence Associations, Resolution No. 9/63.

#### 11. Resolutions Discussed but Not Submitted

No. 6/62—Conversion of LAA Regiments

WHEREAS LAA Artillery has been obsolete for a number of years, and WHEREAS LAA Unit Commanders signed a request to the effect that Units be converted to Field at RCAA meeting in Ottawa in 1961,

Now Therefore Be It Resolved

That this Association respectfully request Army Headquarters to proceed with the conversion of AA units and authorize the issue of equipment.

This resolution in a similar form was submitted to the Chief of the General Staff last year. Because of the answer received to last year's resolution and the fact that this matter is receiving the active consideration of Army Headquarters, the resolution was withdrawn.

Prior to the printing of this report the conversion of all anti aircraft units was approved by Army Headquarters.

#### No. 7/62—Pension Rights for Call Outs

This matter was discussed but as the matter had been brought forward in previous years and submitted to the Conference of Defence Associations with no success the matter was dropped.

## No. 8/62—Militia Staff Course

Suggested changes in studying and qualifications were discussed. As new requirements regarding this course had just been published by Army Headquarters it was decided that further comment should be withheld until they had been tried. It was pointed out that there was a difference between Commands regarding requirements for this course and units were advised to take such problems to their individual Area or Command.

## 12. Canadian Artillery Memorial, Les Tilleuls, Thelus, Pas-de-Calais, France

A motion was approved to pay the Commonwealth War Graves Commission for the annual maintenance costs of the memorial.

## 13. Delegates to 1963 General Meeting

Delegates to the 1963 General Meeting were approved as follows.

- 1. Officers of the Association and members of the committee
- 2. One per Regiment and Independent Battery
- 3. (a) All Artillery Officers commanding a Militia Group
  - (b) Artillery Officers on Headquarters of the Militia Groups under command of each Command or Area not represented by a Militia Group Commander may send one delegate subject to the following:
    - (1) the officer to be of the rank of Lt. Col.
    - (2) priority to be given to the Artillery Advisor.

## 14. Travelling expenses to annual meeting 1963

Travelling expenses to the 1963 Annual Meeting were approved as follows.

- a. Delegates to general meeting (E and W. Commands by Air) if meeting in Ottawa.
- b. Executive committee to committee meetings.
- c. Officers of Association or other person nominated by President to represent Association at special meetings called by Army HQ or Conference of Defence Associations.
- d. Travel by air for (b) and (c) if train journey each way over 24 hours.
- e. Rates and allowances to be
  - (i) Eastern and Western Commands
    - (a) Return air fare (economy) from nearest airport
    - (b) Return railway fare to nearest airport
    - (c) Necessary taxi fares
    - (d) If travelling by rail as for (ii) below
  - (ii) Central and Quebec Commands
    - (a) First Class return railway ticket
    - (b) Lower berth and/or chair car each way
    - (c) Allowance meals etc. at rate of \$2.00 per meal en routeminimum \$2.00.
  - (iii) Allowance at meetings:

\$12.00 per day-two days for delegates, three days for executive committee. Those whose train or air connections necessitate an extra day may claim for an extra day.

### 15. Expenses—Members of the Executive Committee

The meeting approved the payment of any expenses incurred by members of the executive during the coming year. It was suggested that if an executive meeting is necessary it might be held elsewhere than in Ottawa.

## 16. Appointment of Trustees

The meeting approved a motion that the present trustees continue in office.

## 17. Annual Meeting 1963

The meeting approved the holding of the 1963 annual meeting in Ottawa.

The suggestion was made for consideration later that the 1967 meeting be held in Montreal should this city be the site of the 1967 World's Fair.

#### **18.** Notices of Motion

1. Notice of motion was given that items 6, 7 and 8 of the agenda, namely (1) Delegates to the next general meeting, (2) Authoriza-

tion of travelling expenses, and (3) Expenses of the executive committee to special executive meetings, be added to the Rules of the Association.

2. Financial Year

The fact that the financial year is not mentioned in the Rules of the Association was drawn to the attention of the meeting. Notice of motion was given to propose such an amendment next year.

As a result of these notices of motion suggested amendments to the Rules are outlined below for discussion purposes at the next general meeting. References are as follows:

- (a) Delegates to next general meeting (see 6 below).
- (b) Authorization for travelling expenses (see 5(1), (2) and (3) below.
- (c) Allowances (see 5(4) below).
- (d) Financial year (see 4 below).

Also included in these suggested amendments are the following items for which authority is asked for every year.

- (e) Expenses-members of the executive committee (see 5(1)(b) below).
- (f) Appointment of trustees (see 2(2) below).
- (g) Delegates to the Conference of Defence Associations (see 2(2) below).
- (h) Business of the Association (see 2(1) below).

Two other items in the Rules which might be amended are:

- (i) Amend Section 4 re offices of Secretary and Treasurer (see 1 below).
- (j) The practice of a nominating committee started last year (see 3 below).

The suggested amendments in detail are:

1. Section 4 Lines 6 and 7

Delete lines 6 and 7 and substitute

The offices of Secretary and Treasurer may be combined and that of Assistant Secretary Treasurer created. All officers shall be elected annually.

2. Section 5

(1) After "For the administration" in line one insert "and to conduct the business".

(2) Add a new paragraph to Section 5.

The Executive Committee shall, when required, appoint three trustees to advise on the investment of funds or the selling of securities. The Executive Committee shall also appoint the requisite number of delegates and alternative delegates to attend the Conference of Defence Associations.

3. Section 15

After "Auditor" in line 9, delete line 10 and substitute "by a nominating committee appointed by the executive committee".

4. Section 22

Delete the whole section and substitute-

## Financial Year and Auditing of Accounts

The financial year of the Association shall be from September 1st to August 31st of the next year, both dates inclusive. The accounts shall be audited annually and presented to the next general meeting. A Chartered Accountant, International Accountant, or other qualified Accountant shall be appointed annually by the General Meeting to audit the accounts of the Association.

5. Section 23

Change the heading to Travelling Expenses and Allowances and delete the whole section and substitute-

(1) Unless otherwise decided at a general meeting travelling expenses and allowances are authorized for

- (a) executive committee and delegates to a general meeting,
- (b) executive committee to special executive committee meetings,
- (c) officers of the Association or other person nominated by the President to represent the Association at special meetings called by Army Headquarters or other meetings,
- (d) Association delegates to the Conference of Defence Associations annual meeting if expenses are not paid by the Department of National Defence.

(2) Unless otherwise decided at a general meeting travelling expenses are authorized for travel by air if the train journey each way is over twenty-four hours, and travel by train if the train journey is less than twenty-four hours. Normally Eastern and Western Commands will be allowed to travel by air if the general meeting is held in Ottawa. If the meeting is held at Shilo, Eastern, Quebec and Central Commands and British Columbia Area will be allowed air travel.

(3) Rates and allowances shall be

(a) If travelling by air

- (i) return economy air fare from nearest airport,
- (ii) return first class railway fare to nearest airport, and
- (iii) necessary taxi fares;
- (b) If travelling by rail
  - (i) first class return railway fare,
  - (ii) lower berth and/or chair each way, and
  - (iii) meal allowance of \$2.00 per meal en route;

(c) If travelling by privately owned automobile the same rates and allowances are permitted as for travelling by rail.

(4) Allowances while attending meetings at elsewhere than an Army Establishment shall be \$12 per diem. or as decided at a general meeting. Two days are authorized for delegates and three days for members of the Executive Committee. Those whose train or air connections necessitate an extra day may claim for an extra day.

6 Add new Section 27

## Authorized Delegates to General Meeting

27. Unless otherwise decided at a general meeting, delegates authorized to attend a general meeting shall be

- (1) Officers of the Association and members of the Executive Committee,
- (2) One officer per Regiment and Independent Battery. An officer from a Regiment or Independent Battery on the Executive Committee shall represent his unit.
- (3) (a) All Artillery Officers commanding a Militia Group, or
  - (b) Militia Groups not represented by a Militia Group Commander may send one artillery officer provided that
    - (i) the officer is of the rank of lieutenant colonel, and
    - (ii) priority be given to the Artillery Advisor.

## **19.** Delegates to the Conference of Defence Associations

The executive was authorized to appoint six delegates to represent the Association at the Conference and to pay any expenses incurred, and that travel rates should not exceed those authorized for an executive committee meeting.

#### 20. Appointment of Honorary Colonel Commandant

The meeting was advised that the Honorary Colonel Commandant had received a letter from Army Headquarters advising that they wished concurrence in changing the title of this appointment to Colonel Commandant. The meeting approved this suggestion and the Honorary Colonel Commandant was requested to inform the Adjutant General accordingly.

## 21. Honorary Life Membership for the Master Gunner

The meeting unanimously approved the election of the Master Gunner of St. James' Park, General Sir Robert Mansergh, GCB, KBE, MC, as an Honorary Life Member of the Association.

## 22. Regular Officers in Attendance

The Adjutant General, Major General W. A. B. Anderson, OBE, CD, was in attendance and participated in discussions. On the invitation of the President he spoke to the meeting and extended greetings and best wishes from the Chief of the General Staff and the Army Council. He expressed the regrets of the Chief of the General Staff at not being able to be present.

The Adjutant General explained in some detail the problems involved in the expenditure of the military dollar and the points that must be considered by the Army Council in the allotment of funds. He also pointed out that the intention of the Militia will continue to be training in the National Survival role and in addition it is hoped more corps training will be done. Gunner family problems were mentioned and the importance of maintaining the esprit de corps of the gunners at the high level at which it now is was stressed.

General Anderson concluded his remarks by expressing his appreciation of the role the Association has played in enabling the Master Gunner to visit Canada.

Col. E. G. Brooks, DSO, OBE, CD, Director of Artillery and Col. E. M. D. Leslie, DSO, CD, Commandant, Royal Canadian School of Artillery, were in attendance at some sessions of the annual meeting. In addition the Association was pleased to welcome Regular Force officers on the establishment of the School.

The President expressed regrets that Col. J. M. Delamere, ED, CD, Director of Militia and Cadets, who had intended to be present, was unable to attend the meeting owing to illness.

The Director of Artillery addressed the meeting and discussed the Standing Orders he had issued in draft form. He stated that some amendments would be made from experience gained during the Master Gunner's visit, and that the final Standing Orders will be issued, he hopes, in December. He requested units to notify him of the number of copies required. The Standing Orders have since been published and distributed.

The first issue of The Bulletin, which he had hoped would replace The Canadian Gunner, has proved to be very expensive and he would welcome suggestions of some other way of disseminating information regarding the Gunner Family.

## 23. Presentation to the Royal Canadian School of Artillery

The meeting approved the purchase of a Crest for the RCA Mess which would be placed over the main entrance.

## 24. Patron and Vice-Patrons of the Association

The meeting authorized the executive to request His Excellency, the Governor General, and the Lieutenant Governors of the Provinces, to be patron and vice-patrons respectively of the Association. Provision for such action is contained in Section 3 of the Rules of the Association.

Subsequent to the annual meeting the President wrote to His Excellency the Governor-General requesting him to become Patron of the Association. This His Excellency graciously consented to do. In his letter the President pointed out that all Governors-General from 1876, when the Association was formed, to 1939, had been patrons and that we wished to revive such a practice.

Up to the time of printing the Lieutenant-Governors of the Provinces of Alberta, British Columbia, New Brunswick, Newfoundland, Prince Edward Island, Quebec and Saskatchewan had accepted the President's invitation to become Vice-Patrons of the Association.

## 25. RCA Bulletin

The meeting authorized an expenditure of \$300. to assist the Director of Artillery in defraying expenses of the publication of this Bulletin. This matter is to be reviewed again next year.

## 26. Extension of Membership

Brig. R. T. DuMoulin expressed the thought that membership in the Association should be expanded. The Secretary pointed out that a letter had been sent to all units as a result of discussions on this matter last year and only two additional individual members had been added. It was decided to leave this problem to the incoming executive.

## 27. Business of the Association

The meeting authorized the executive to conduct the business of the Association until the next general meeting.

## 28. Motion of Thanks

A unanimous motion of appreciation was passed to Col. E. G. Brooks, DSO, OBE, CD, Director of Artillery, and his staff for the outstanding work done by them in arranging the details of the Master Gunner's visit.

Again the meeting was unanimous in expressing thanks to Col. E. M. D. Leslie, DSO, CD, Commandant, Royal Canadian School of Artillery, for the excellent arrangements made by him and his staff for the annual meeting.

A motion of thanks to the outgoing executive was presented and passed.

### **29.** Election of Officers

The nominating committee reports was presented by Brig. E. R. Suttie, chairman. The slate of officers proposed was:



## 31. Master Gunner's visit to the General Meeting

At 11 a.m. Friday, October 5th, the business meeting was recessed to welcome the Master Gunner St. James's Park, General Sir Robert Mansergh, GCB, KBE, MC.

The President welcomed him on behalf of the Association, and expressed deep appreciation to the Master Gunner for his kindness in accepting the invitation of the Honorary Colonel Commandant to visit Canada. He pointed out that this occasion is a highlight in the history of the Association and to all Gunners in Canada.

The Master Gunner was then presented by the President with a framed scroll making him an Honorary Life Member of the Royal Canadian Artillery Association.

General Mansergh expressed his appreciation on being accorded this honour and thanked the members of the Association for their kindness.

He refreshed the memory of those present of Gunner problems and stated that these were similar in both the United Kingdom and Canada. He stressed the traditions of the Gunner family and expressed the belief that they were being carried on in Canada in good hands. His trip across Canada was a great pleasure to him and he had enjoyed immensely meeting Gunners of all ranks and was looking forward to the remaining part of his journey.

On completion of his remarks he presented to the Regiment through the Colonel Commandant a framed set of medals. These will have a permanent place at the home mess of the Regiment.

At this point the Master Gunner and his party retired from the meeting which was then adjourned in order that the members might reassemble in the Gun Park of the Royal Canadian School of Artillery.

At the Gun Park, in which were present in addition to the delegates, many officers and men of the Regular Army and their dependants, General Mansergh presented to the Royal Regiment of Canadian Artillery a 15 pounder gun as a gift from the Royal Regiment of Artillery. He informed the gathering that Her Majesty, Queen Elizabeth II, Captain General of the Regiment, had approved the presentation of this gun which had borne the body of Queen Victoria during her funeral. The plaque, presented with the gun, which was prepared at Woolwich Armouries, notes that the gun of Boer War vintage has been

"entrusted to the Royal Regiment of Canadian Artillery by the Royal Regiment of Artillery as a symbol of the comradeship and unity of purpose as was demonstrated in two major wars by all British gunners. The gun carriage is one of those which was used to carry the body of her late Majesty Queen Victoria during her funeral on 2nd February 1901, hauled by a team of 109 Battery, Royal Field Artillery."



## 38. Report on Resolutions Passed at Conference of Defence Associa-10-12 January 1963 with Official Replies

## Resolution No. 1/63 Corps Training

WHEREAS it is essential to the preservation of efficiency that the skills peculiar to the corps to which an officer belongs be encouraged and tested; and

WHEREAS the continuance of the present conditions is having the effect of reducing the interest of, and the standards of training reached by the officers in their special-to-corps skills;

WHEREAS these skills are still required for the proper execution of corps roles;

Now THEREFORE BE IT RESOLVED that special-to-corps examinations be reinstated as an integral requirement for promotion and appointment to all officer ranks.

#### Reply

1. Consideration is being given to expanding the scope of officer training by the introduction of:

- a. A qualification course for the rank of captain which will include special-to-corps subjects.
- b. Special-to-corps subjects in the field officer qualification course.

2. Before this can be done, a practical method of conducting special-tocorps training and examinations must be found within our capabilities. It is proposed to discuss this matter at the next annual meeting of the Conference of Defence Associations.

## Resolution No. 2/63

## **Qualification of Lieutenant-Colonels**

WHEREAS it is essential that Militia units be commanded by properly qualified officers; and

WHEREAS Officers Commanding Lieutenant-Colonels' Command should be adequately qualified in field operational duties, staff procedures and in administrative functions; and

WHEREAS the Militia Field Officers' Course is not adequate in this regard; and

WHEREAS the present ruling is that Field Officers' Course qualifies an officer for the command of a unit of Squadron, Battery or Company in National Survival Operations only; and

WHEREAS the experience of this Association is that production of a sufficient number of staff-trained officers is feasible; and

WHEREAS the present policy will not produce Lieutenant-Colonels which are adequately qualified in all phases of military knowledge;

Now THEREFORE BE IT RESOLVED that as a prerequisite for appointment to Lieutenant-Colonels' Commands, an officer successfully complete the Militia Staff Course or if an officer of the RCAMC or RCDC, the Militia Staff Course or the senior officers' qualifying course.

## Reply

1. A proposed expansion in the scope of officer training will in large part meet the deficiencies in the qualification of senior officers attributed by this resolution. Further qualification by means of the Militia Staff Course is considered desirable but not essential for command of major units.

2. A programme which provides all potential Lieutenant-Colonels with Staff training is not feasible within our present training capabilities. Furthermore, a policy of Militia Staff Course qualification as a prerequisite for appointment to command of major units would prove too restrictive for practical application. For instance the Militia Staff Course is a prerequisite for officers appointed as Militia Group Commanders. From past experience, it has been necessary to take exceptions in order to obtain the most suitable officers available.

## **Resolution No. 3/63** Officer Qualification

WHEREAS the most effective method of securing suitable junior Militia Officers with the desirable educational background is direct recruitment of students while still attending university or other institutions of higher learning; and

WHEREAS many units are faced with the prospect of no suitable replacements for this level of command; and

WHEREAS the necessity of summer employment forces such students interested in military training to join the University Contingent COTC, rather than through regular Militia units not able to provide full summer training;

Now THEREFORE BE IT RESOLVED that a system of officer qualification be re-established similar to the former Method D, whereby officer training is given on a unit basis during the winter training season, followed by attachment to Corps Schools and other Regular Army establishments during summer months, permitting much more thorough and comprehensive officer training than at present available.

#### Reply

1. The reintroduction of summer-long qualification courses for Militia officers would entail an additional workload for Corps Schools and other Regular Army units which cannot be met under present manpower and budgetary limitations.

2. From past experience, courses at Corps Schools for Militia personnel have had to be cancelled because of a lack of candidates. It is not intended therefore to re-introduce this type of course. We are however, exploring the possibilities of conducting Royal Schools.

## Resolution No. 4/63 Specialty Training

WHEREAS one of the aims of Militia training is to prepare individuals, units and formations to carry out support to the field forces; and WHEREAS it is necessary to have qualified specialists in order to prepare RCAC, RCA and RCIC units to support the field force;

Now THEREFORE BE IT RESOLVED that training policy be altered to include RCAC, RCA and RCIC specialties and that standards be established on a Block basis to group 2 level equivalent to those previously prescribed in GSI 54/17; all personnel achieving group qualification to be entitled to trades pay.

### Reply

1. Studies have been conducted to determine how best to provide a specialty for other ranks of RCAC, RCA and RCIC. The limitations in training time and other resources make it impractical to reintroduce corps specialities in the variety and to the standards formerly prescribed in GSI 54/17.

2. In keeping with the Militia's training objectives a specialty has been proposed which will be devoted in part to selected corps subjects and in part to advanced survival training. Subject to budgetary considerations and subsequent approval these standards will lead to group 2 qualification.

## Resolution No. 5/63

## Junior NCO Qualification

WHEREAS the student Militia and young soldier training programme has been a great boon to the Militia; and

WHEREAS the candidates under this programme attain trained Militiaman standards in the first year; and

WHEREAS in SOME AREAS these candidates go on to gain junior NCO and certain trades qualification in their second year;

Now THEREFORE BE IT RESOLVED that this training programme be of two years duration in all Commands and that each candidate be trained in his second year for either tradesman or junior NCO qualification.

#### Reply

1. For high school students who undertake this training a three year progressive programme has been in effect in Western and Central Commands. A similar programme will reach full development in the other Commands by 1964. Progression in training is achieved as follows:

a. First year. Qualification of trained militiaman.

- b. Second year. Qualification of junior NCO or in a selected trade.
- c. Third year. Employment as an assistant instructor on this programme or on other summer training programmmes.

## Resolution No. 6/63 Training

WHEREAS many units are experiencing difficulty in complying with regulations requiring second class qualifications on range practices before NCO training, trades testing, trained militiaman standards, etc, may be undertaken and/or completed for the reasons of: a. Lack of suitable ranges; and

b. Shortage of weapons.

Now THEREFORE BE IT RESOLVED that Commands be authorized to waive second class range qualifications temporarily in such cases to enable personnel to proceed with advanced training.

#### Reply

It is considered essential that the Militiaman be trained to at least second class shot standard in the use of the C1 rifle through firing practices on the open range. Where open ranges are not available to conduct this training on week-ends, firing will be done at summer camp.

#### Resolution No. 7/63

# Courses Qualifying — RCDC School

WHEREAS medical resources are estimated to be inadequate to meet the needs following a national disaster; and

WHEREAS it may be necessary in the early stages of a national emergency for the RCDC to be employed to assist the CFMS in the role of care, sorting and evacuation of mass casualties; and

WHEREAS the RCDC(M) has undertaken training in the 24 Basic Supporting procedures; and

WHEREAS training which is not practiced is soon lost;

Now THEREFORE BE IT RESOLVED that the Courses Qualifying at the RCDC School be continued and that an additional Militia courses of collective training be established. This course to practice qualified RCDC (M) personnel in the tactical development and technical operation of an ambulance centre (ATC) in support of CFMS in its national survival role.

#### Reply

1. There has been no thought of discontinuing the courses referred to in this resolution. These courses are held periodically at the RCDC School for Regular dental officers and vacancies are allotted to Militia dental officers as required.

2. Training in the tactical deployment and technical operation of an ambulance centre (ATC) in support of CFMS in survival operations cannot be undertaken until the role and doctrine of CFMS in survival operations have been established.

## Resolution No. 8/63

## Formation of Militia Units

WHEREAS it is now stated AHQ policy to establish new Militia units in centres outside of target areas; and

WHEREAS new units will require fully-trained Regular Army instructors to properly train them and fully qualified Clerks Admin and Clerks Storeman to properly administer them; and

WHEREAS it will take several years to train new units to take their effective place in any target area re-entry plan; and

WHEREAS Militia units do not have the time, money, establishments, stores, equipment or authority to raise new units themselves;

Now THEREFORE BE IT RESOLVED that all assistance be given to units located now in the target area so that they may relocate and/or establish new sub units in areas that will be effective and recruit to establishment.

#### Reply

1. Within budgetary and Regular Army manpower limitations, policy has always been to promote the growth and efficiency of the Militia and to this end to give maximum assistance and cooperation to Militia units. Further, in keeping with Army national survival planning, Militia units are encouraged to recruit to establishment either in existing locations or to plan expansion in new localities where there is sufficient evidence that a strong, efficient sub unit can be maintained. This is being done to the extent that financial resources will allow.

## **Resolution No. 9/63**

### **Permanent Assistance**

WHEREAS the reduction of training time allotted to Militia personnel has resulted in an increased work-load on Militia call-outs; and

WHEREAS the number of Militia call-outs presently authorized cannot efficiently cope with the increased work-load;

Now THEREFORE BE IT RESOLVED that the number of Militia call-outs be increased to ensure maximum unit administrative efficiency.

### Reply

1. The number of Militia personnel employed as Permanent Orderly Room Assistants and Permanent Quartermaster Assistants is under review. Consideration is being given to limited increases where a genuine need for additional assistance has been established.

## Resolution No. 10/63 Call-Out Procedure

WHEREAS the Minister of National Defence finds it expedient, in order to conduct the training and administration of The Canadian Militia in an efficient manner, to call-out from time to time soldiers in the Canadian Army Militia, to fill specific vacancies; and

WHEREAS some of these personnel have been filling such vacancies and carrying out their duties under the call-out procedure, for periods in excess of five years; and

WHEREAS the terms of service in respect to call-out do not provide job security, thus, in some cases, failing to attract to the position an officer or man of the calibre desired;

Now THEREFORE BE IT RESOLVED that an immediate study be made with a view to adopting a more efficient system of employing members of the Militia on continuous Army duty basis, that is:

- a. Any man called out should be called out for a specific period which, it shall be less than six months, shall be upon the same terms as present exist.
- b. If any man be called out for a period in excess of six months then his employment should not be terminated on less than six months notice (except for cause) or unless he shall contract otherwise with the Canadian Army at the commencement of his term of service.
- c. That any such call-outs serving for a period over six months be provided with unemployment insurance coverage.

#### Reply

1. The employment of members of the Militia on continuous Army duty with Militia units was instituted upon the recommendation of the Board of Officers on Organization of the Canadian Army (Reserve Force) in 1954. The purpose was to improve administration and to provide continuity.

2. ĆAO 94-2 which sets out the conditions of employment is quite specific in stating that employment is on a temporary basis. The commanding officer, in the main, is the authority for employment and/or dismissal because he is the best judge of the standard of work being performed by the incumbent. If the commanding officer is dissatisfied he may terminate the employment on short notice. If, on the other hand, he is satisfied with the work being performed, the employment continues indefinitely as would be the case with a civilian company.

3. It is considered that the current terms of service offered to the members of the Militia employed on continuous Army duty compare favourably with other employment in civilian life and, furthermore, that this employment must be equated to civilian life rather than to the Regular Forces. No civilian firm would undertake a contract requiring six months' notice to be given to clerical employees or warehouse storemen for termination of employment for economy reasons. Hence it is not agreed that it is necessary to change the present terms of service. Where employment of a member of the Reserves on continuous Army duty is to be ceased for reasons other than unsatisfactory service the maximum amount of notice possible will, however, continue to be given.

## Resolution No. 11/63 Army Chaplains

WHEREAS the present establishment of Army Chaplains is restricted to the extent that many units are unable to benefit from the service and counselling offered by the Chaplain Services, especially at such times as Remembrance Day, Christmas, etc; and

WHEREAS many of the younger clergy are eager to associate themselves with Militia units to familiarize themselves with Service organization and proceedings in order to better minister to the needs of the troops, in the event of future hostilities;

Now THEREFORE BE IT RESOLVED that the establishment for Chaplains be enlarged so that at least one Chaplain is available for every unit.

### Reply

1. The establishment of Command chaplain units provides a total strength of 124 protestant and 96 roman catholic chaplains. This total is supplemented by the attachment of chaplains from the Supplementary Reserve to Militia units as required. The need for additional chaplains and the best method of providing them for the Militia will be investigated.

## Resolution No. 12/63 Role of the Militia

WHEREAS the defence commitment of Canada in event of an attack would require a large and sudden increase in our armed forces; and

WHEREAS this manpower needed for total defence must come from the civilian population; and

WHEREAS this manpower must be trained to be effective; and

WHEREAS the Reserve Forces of Canada provide a nucleus around which this needed manpower can be trained; and

WHEREAS there seems to exist a lack of public recognition of the need for this training;

Now THEREFORE BE IT RESOLVED that this Conference recommend that the general public be kept fully advised by our government of the role of the Reserve Forces and their importance in the defence programme of Canada.

#### Reply

1. The need to keep the public informed of the role of the Reserves in relation to Canada's defence plans is appreciated. It is the policy of the Department of National Defence to publish as much information as possible on this topic. The publicity given to the Special Militia Training Programme is an example of this.

## Resolution No. 13/63

#### Army List

WHEREAS an up-to-date Canadian Army List would be most useful not only to members of the Regular Army and of the Militia but also to the public in general; and

WHEREAS no Army List except for the Army List Regular Forces Gradation List has been issued since 1945; and

WHEREAS some officers have been serving for 17 years without their names appearing in print on any Army List; and

WHEREAS it appears that most of the historical and other material has already been compiled and that comparatively little work remains to be done;

Now Therefore Be It Resolved as follows:

1st —That an Army List composed of three parts as hereinafter mentioned be published in book form.

2nd-That such list be placed on a minimum free issue scale.

3rd—That such list be sold to the public at a profit.

4th That such list be composed of three parts as follows:

PART I – Regular and Militia.

Listing all units, their history, location, honorary officers and COs (published every five years).

PART II –Gradation List (Reg).

PART III-Gradation List (Militia)-including Supplementary Reserve (for majors and above). Published annually.

#### Reply

1. The following decision has been taken concerning the publication of the Army List:

- a. Volume 1. The Minister announced at the Conference of Defence Associations in Jan. 63 that Volume 1 of the Army List would be published in 1963 as soon as funds became available. This volume will contain information that changes little from year to year for both the Regular Army and the Reserves, such as command structure, general organization, brief histories of corps and units, badges, battle honours, etc. A free distribution list and the selling price of the volume will be established at the time of publication.
- b. Volume 2-The Regular Army Gradation List. The Regular Army Gradation List will continue to be published as at present, but the corps and regimental histories will be deleted therefrom after Volume 1 is published. This is not a bound volume and it will not be offered for sale to the public as it is not considered to have any value outside the Regular Army. Furthermore, it is a "Restricted" document. The distribution of this volume is such that all Regular Army officers have access to a copy.
- c. Volume 3-The Militia List. Publication of a Militia List, to contain unit slates of officers of the Militia, a gradation list of Supplementary Reserve officers of the rank of major and above and unit slates of COTC Contingent officers, has been deferred until the relevant data concerning the Militia is recorded on machines. Any attempt to produce this volume manually from the information now available would result in a volume which would be well out of date upon publication and which would not justify the extra staff and expense involved. No estimate can be given as to when a Militia List might be established. Publication of this volume will be on an annual basis with free distribution. As it will be a "Restricted" document, it will not be offered for sale to the public.

## Resolution No. 14/63 Vehicle Safety Belts

WHEREAS the Department of National Defence is vitally interested in all aspects of safety; and

WHEREAS the Canadian Safety Council are continually advocating the installation of vehicle safety belts; and

WHEREAS at the present time Department of National Defence vehicles are NOT equipped with safety belts;

Now THEREFORE BE IT RESOLVED that, where practicable, all vehicles in the Department of National Defence be modified to include the installation of seat belts for the safety of drivers and passengers, especially in staff cars and station wagons.

#### Reply

1. The use of seat belts for the safety of the driver and passengers in service vehicles operated mainly on highways has been approved. Procurement of belts is dependent on the availability of funds.

#### Resolution No. 15/63

## **Transport** — **Training Allocation**

WHEREAS for the National Survival role, transport has been dispersed in storage at Command level; and

WHEREAS Militia units have been given a minimum of various forms of transport for the training and administration including panel trucks; and

WHEREAS communications are vital in the survival role; and

WHEREAS such a role can be exercised on existing roadways;

Now THEREFORE BE IT RESOLVED that authority be granted for appropriate vehicles to be modified to enable them to be fitted with wireless attachments for use with C42 sets so that they may be used for training purposes in Militia units.

#### Reply

1. Appropriate instructions are being prepared which will detail a method of strapping the C42 set into the panel truck,  $\frac{3}{4}$  ton,  $4 \ge 4$  and which will permit the drilling of holes in the fenders of that vehicle to mount the aerial. Installation of the C42 set in other type vehicles may be done by means of a light rope lashing or other local improvisation. Extensive modification of these vehicles by the fitting of attachments for the installation of the C42 set is not contemplated.

### Resolution No. 16/63

## Assistance re Purchase of Authorized Distinctive Dress

WHEREAS the Department of National Defence has always provided units with funds to purchase authorized distinctive dress; and

WHEREAS the allowance payable by regulations is fixed; and

WHEREAS the purchase prices are appreciably higher; and

WHEREAS units have to pay this extra amount from regimental or unit funds, thereby creating an additional financial burden on such units;

Now THEREFORE BE IT RESOLVED that Army Headquarters be requested to review the situation from time to time to ensure that the amount allotted to units is based on current market price.

#### Reply

1. It is appreciated that the grants prescribed by regulations for the purchase of band uniforms and of kilts may no longer be in keeping with

market prices. This situation will be reviewed with a view to increasing the amount of particular grants where required.

## Resolution No. 17/63 Militia Accommodation

WHEREAS Militia units are at present in greater strength and more active than ever before in history; and

WHEREAS the Militia urgently need more space for training, stores and equipment and are now critically short of it to the detriment of their assigned role; and

WHEREAS any construction, especially during winter, is of benefit to the country as a whole;

Now THEREFORE BE IT RESOLVED that DND undertake an extensive construction programme to provide the Militia with sufficient space in which to train and prepare for national survival operations as soon as possible.

#### Reply

1. Army Headquarters is aware of the need to provide adequate accommodation for Militia units. A list of those locations where accommodation is needed is maintained at Army Headquarters. These locations are listed in order of priority by Provinces, based on recommendations made by the Commands concerned.

2. The extent of the Army's programme to provide accommodation is dependent upon the availability of funds. Such funds are allotted specifically each year in the approved estimates. While there has been some progress, the funds available in recent years have not been sufficient to permit an extensive programme of armoury construction.

#### Resolution No. 18/63

## **Reallocation of Equipment for Training Purposes**

WHEREAS troops recruited for the SMTP (national survival) courses have had a surfeit of the type of training which maintains the interest of ordinary troops; and

WHEREAS it is essential to hold the interest of SMTP trained troops; and

WHEREAS more equipment is required to maintain their levels of training and interest; and

WHEREAS there exists equipment held in reserve outside probable target areas:

Now THEREFORE BE IT RESOLVED that a reallocation of the scale of issue be considered for training purposes.

#### Reply

1. The scales of equipment required by the Militia in survival operations are published in CAFS 23.300. Procurement and distribution of the majority of the scale items are underway or have been completed. However, procurement of some items has had to be deferred as a result of the foreign exchange emergency which arose in 1962.

2. Normally the allocation of items required for Militia survival training is the responsibility of General Officers Commanding Commands. However, because of the foreign exchange emergency, direction has been given that there will be no distribution of training stores, other than radiac instruments, from central stocks to Commands. Direction has also been given that only those items available within Command stocks will be issued for training and that these issues will be subject to the state of training of the unit, availability of accommodation and personnel and availability of Command funds for the movement of items.

#### Resolution No. 19/63

## Award for Outstanding Service

WHEREAS having reference to resolution 40/60 passed at the last annual meeting of the Conference of Defence Associations and observing that present policy does not permit suitable recognition for outstanding services to the Militia and Reserve Forces; and

WHEREAS the Conference of Defence Associations endorses the desirability of there being a suitable award, not only involved with length of time served, for outstanding service to the Militia and Reserve Forces;

Now THEREFORE BE IT RESOLVED that consideration be given at Cabinet level to the institution of a Military and Civil Division of eligibility for a suitable medal to be awarded to persons who have rendered outstanding services to Canada and who cannot under existing authority receive recognition for such services; and that a delegation be appointed to wait upon the appropriate authority towards this end.

#### Reply

1. It is contrary to Service tradition to present awards for outstanding service to the Army or a component of the Army. Service to the country has always been the criteria for awards other than those for personal bravery or distinguished conduct in action against an enemy.

#### Resolution No. 39/63

WHEREAS the objects of the Conference of Defence Associations are, among other things, to consider the problems of National Defence and to make such recommendations to the Government of Canada as may appear expedient; and

WHEREAS the absence of tactical nuclear weapons would render our forces totally incapable of fulfilling their roles in the event of thermonuclear attack by a well equipped enemy;

Now THEREFORE BE IT RESOLVED that the Government of Canada be advised that, having regard to the information available to this Conference, it is the opinion of this Conference that the Regular Armed Forces of Canada should be equipped with the required tactical nuclear low yield weapons.

## **Constitution of the Conference of Defence Associations**

#### Name

1. The name of the organization shall be "Conference of Defence Associations".

#### Object

2. The object of the Conference is to consider the problems of National Defence, to assist the Government of Canada in placing these problems before the people of Canada, to co-ordinate the activities of the service associations in matters of common interest in all services, to make such recommendations to the Government of Canada as may appear expedient, and generally to promote the welfare of the defence forces of Canada as a whole.

### Meetings

3. The Conference shall meet at Ottawa at such time as may be determined by a meeting of the Conference or at the call of the Chairman, or at the request of the Secretary-Treasurer in writing by the representatives of four or more member associations.

#### Representatives

4. The following associations shall be members of the Conference and shall be entitled to send representatives to meetings of the Conference:

The Naval Reserve Consulting Group (NRCG)

The Royal Canadian Armoured Corps Association (Cavalry) (RCACA)

The Royal Canadian Artillery Association (RCAA)

The Military Engineers' Association of Canada (MEAC)

The Canadian Signals Association (CSA)

The Canadian Infantry Association (CIA)

The Royal Canadian Army Service Corps Association (RCASCA)

The Royal Canadian Ordnance Corps Association (RCOCA)

The Royal Canadian Electrical and Mechanical Engineers Corps Association (RCEMEA)

The Defence Medical Association (DMA)

The Royal Canadian Army Pay Corps Association (RCAPCA)

The Royal Canadian Dental Corps Association (RCDCA)

The Canadian Military Intelligence Association (CMIA)

The Cadet Services of Canada (CS of CA)

5. The Royal Canadian Air Force (Reserve) shall be entitled to send representatives to all meetings of the Conference. This body, forming an association in nature similar to the existing associations, such association shall be entitled to become a member association without further formality. Such association shall be entitled to appoint four (4) representatives to meetings of the Conference.

6. Further organizations may be elected member associations by any meeting of the Conference.

7. Each member association shall be entitled to appoint representatives as under who shall remain as representatives until their successors have been appointed by it and the names of such successors communicated to the Secretary-Treasurer of the Conference:

## Officers

8. The officers of the Conference shall be a chairman, a vice-chairman, a secretary-treasurer, an assistant secretary and an assistant treasurer, who shall be elected at each regular meeting of the Conference and shall hold office until their successors are elected. The officers of the Conference. 8a. The executive committee of the Conference shall consist of the chairman, the vice-chairman, the immediate past chairman, and the secretary-treasurer, provided however, that the Executive Committee shall always include at least one representative from each of the services having associations which are members of the Conference. Any service not so represented shall be entitled to appoint an additional member to the Executive Committee.

9. Should any of the offices set out in paragraph 8 become vacant between the meetings of the Conference, the vacancies will be filled from among the representatives by postal vote of the presidents of the member associations. Any representative elected to fill such vacancy shall hold office until the next meeting of the Conference convenes. The postal vote shall be taken under the supervision of the Secretary-Treasurer except in the case of a vacancy occuring in that office when it shall be taken under the supervision of the chairman.

#### Committees

10. There shall be an advisory committee which shall meet at the call of the chairman or, if the chairman is unable to act, at the call of the vice-chairman. The advisory committee shall consist of the Secretaries of the member associations. If a secretary is unable to attend a meeting of the advisory committee, he may delegate a substitute to act in his place. 11. The chairman or, in the event of the chairman being unable to act, the vice-chairman may, between meetings of the Conference, create such committees as he may consider necessary to study problems of interest to the Conference and to report, and may generally define the terms of reference

#### Finance

12. The expenses of the Conference, other than those borne by the Crown, shall be met by assessment upon the member associations in proportion to the grants received by such associations from the Crown.

of such committees, their constitution and their powers.

### Voting

13. Each of the member associations shall have one vote on any question put to any meeting of the Conference. However, before any resolution relating to more than one service is forwarded from the Conference, a vote shall be taken on the basis of a single vote per service (the Militia vote shall be determined by the will of the majority of the Militia Associations). Such resolutions shall, unless unanimously concurred in by the affected Service, include a statement of the views of the Service dissenting therefrom.

## RULES OF THE ROYAL CANADIAN ARTILLERY ASSOCIATION

## (Adopted by the General Meeting October 1949 and as amended by the General Meeting November 1957)

#### Name

1. The name of the Association shall be the Royal Canadian Artillery Association.

#### Object

2. The promotion of the efficiency and welfare of the Royal Canadian Artillery and of all matters pertaining to the Defence of Canada.

#### **Patron and Vice-Patrons**

3. The Governor General of the Dominion and the Liteutenant-Governors of the Provinces may be respectfully requested to become Patron and Vice-Patrons, respectively, of the Association.

## **Elected Officers of the Association**

- 4. The Officers of the Association shall consist of:
  - (a) A President (not eligible to serve two consecutive terms).
  - (b) A Vice-President (not eligible to serve two consecutive terms).
  - (c) A Secretary.
  - (d) A Treasurer.

(c) and (d) offices may be combined, and an Assistant appointed, to be elected annually.

#### **Executive Committee**

- 5. For the administration of the Association throughout the year, there will be an Executive Committee consisting of:
  - (a) The President and Vice-President of the Association.
  - (b) One member from those units serving under each Command and Area HQ (Newfoundland Area to be included in Eastern Command). To be elected for one year eligible for re-election.
  - (c) The two immediate past Presidents.
  - (d) Ex-officio:
    - 1. The Honorary Colonel Commandant
    - 2. Past Honorary Colonel Commandants
    - 3. An Advisory Committee of three elected from Supplementary Reserve and Retired Royal Canadian Artillery Officers, Regular and Militia. To be elected for a three year term not eligible to serve two consecutive terms.

The Director Royal Canadian Artillery and Commandants Royal Schools of Artillery and Commanding Officers Regular Artillery may be requested to attend meeting in an advisory capacity as required.

## Members

6. The following are eligible as members:

- (a) All serving Artillery Officers of affiliated units of the Royal Canadian Artillery (Militia).
- (b) Other Serving Royal Canadian Artillery (Militia) Officers who have paid current affiliation fee.
- (c) Ex-Artillery Officers of the Canadian and other British Commonwealth Forces acceptable to the Association.
- (d) Elected Honorary Life members.
- (e) Life Members.
- (f) Associate members:
  - (1) Regular Army Officers Royal Canadian Artillery.
  - (2) Other Commonwealth Artillery Officers serving in Canada.

## **Affiliate Units**

- 7. The following units will be eligible to affiliate with the Association:
  - (a) Headquarters of Commanders, Royal Canadian Artillery and Army Groups, Royal Canadian Artillery of the Militia, and of such other Artillery Militia Commanders as may be formed from time to time.
  - (b) Artillery Regiments of the Militia.
  - (c) Independent Artillery sub-Units of the Militia.
  - (d) Regular Army Artillery Units.
  - (e) Royal Military College and Royal Roads, College Militaire St. Jean.
  - (f) RCN, RCN(R) and Royal Canadian Air Force Units detailed to co-operate with Artillery.
  - (g) Units of the Canadian Officers Training Corps.
  - (h) Cadet Corps affiliated to Artillery Units.

#### **Elected Honorary Life Members**

- (a) Any person who is deemed to have rendered outstanding service to the Artillery may be elected an Honorary Life Member of the Association at a General Meeting. Record of Service in the Royal Canadian Artillery normally to be the dominant factor in selection.
  - (b) Numbers to be limited as may be decided from time to time by a General Meeting.
  - (c) Nominations must be submitted to the Secretary-Treasurer thirty days before Annual Meeting accompanied by reasons and where applicable, by Service history. These nominations will be examined by the Executive Committee who will report their recommendations to the General Meeting.

(d) Voting will be by all eligible voters present on each name submitted and will be carried out in the order of priority as recommended by the Executive Committee.

## Life Member

9. Any Serving Officer RCA (Militia) or ex-Royal Canadian Artillery Officer may make application to become a Life Member by paying a fee of Fifty Dollars. Application will be forwarded to the Secretary and presented to the next General Meeting for consideration.

## **Affiliation Fees**

- 10. (a) Militia Units: Fees will be based on the Artillery officer strength as at 1st September in each year, the rate to be determined each year at a General Meeting.
  - (b) Regular Units: No fees required unless otherwise determined at a General Meeting.
  - (c) Units shown in paragraph 7 (e, f, g, h) will not be required to pay fees.
  - (d) Individual Serving and Ex-officers: An annual fee of \$3.00. Associate members will not be required to pay fees.

## **Rights of Members**

- 11. (a) At a General Meeting all members will have the privilege of taking part in the proceedings other than voting.
  - (b) Voting will be restricted to those set forth in paragraph 12.
  - (c) Only Serving and Ex-Officers of the Royal Canadian Artillery (Militia) and ex-officers of the Royal Canadian Artillery (Regular Army, are eligible for election to office in the Association.

## **Eligible Voters**

- 12. At General Meetings those eligible to vote will be:
  - (a) Elected Officers and members Executive Committee of the Association not representing a HQ or Unit.
  - (b) One representative from each:
    - (i) Headquarters, Commanders Royal Canadian Artillery and Army Groups, Royal Canadian Artillery (Militia) and such other headquarters as may be formed.
    - (ii) Regiment, Royal Canadian Artillery (Militia).
    - (iii) Independent Sub-Unit Royal Canadian Artillery (Militia).
    - (iv) Any serving or ex-Artillery Officer who may be authorized to attend with expenses paid as a representative of a Militia Group HQ or any similar HQ.

The appropriate fees for the previous Association year must have been paid before an individual or Unit representative is eligible to vote.

### **Proxy Votes**

- 13. Any eligible voter or Unit who is not represented at a meeting may:
  - (a) On subjects of which notice has been given send to the Secretary a written vote.

(b) In any case, give "proxy powers" to any other eligible voter, this power to be notified to the Secretary in writing stating whether power is only for specific subjects or for all subjects that may arise. The above to apply to both General and Executive Committee Meetings. For purposes of voting the person or Unit giving the proxy shall be deemed present at the meeting and shall abide by vote of his Proxy.

## **General Meetings**

- 14. (a) A General Meeting of the Association will be held annually, unless otherwise decided at a General Meeting.
  - (b) A Special General Meeting may be called by the President at the request or concurrence of two-thirds of the Executive Committee.
  - (c) All members are eligible to attend. Representatives of affiliated Units as described in paragraph 7 (e, f, g, h) may be asked by the Executive Committee to attend as observers.
  - (d) The General Meetings are to be held at a place and time of year to be decided at General Meetings the exact dates to be decided by the Executive Committee.
  - (e) The President will preside, but in his absence, the Vice-President will take his place or, if not present, the senior serving Militia Officer on the Executive Committee.
  - (f) At a General Meeting the business of the Association will be transacted and such powers as may be deemed fit will be delegated to the Executive Committee.

## **Election of Officers and Executive Committee**

- 15. (a) All Officers and Members of the Executive Committee will be elected by a General Meeting.
  - (b) Nominations will be made as under:

 President Vice-President Secretary Treasurer Advisory Committee Auditor

By the Executive Committee.

- (2) Representatives from each Command and Area by the eligible voters in each Command or Area.
- (c) Further nominations may be made by any member of the Association before voting on the nominations takes place.

## **Resolutions** Committee

16. At any General Meeting where Resolutions are to be presented a Resolutions Committee(s) will be appointed whose duty will be to frame the approved Resolutions in accordance with the opinions expressed by the meeting. The Committee will consist of one member from each Army Command, appointed by the Command and Area Executive Committee members in each Command, and such other members as the President may consider necessary in view of the nature of the Resolutions being presented. The Committee(s) will elect its own Chairman.

## **Changes in Rules of Association**

- 17. (a) Change in Rules of the Association will be made only with the approval of the General Meeting.
  - (b) Any proposed changes will be notified to the Secretary 60 days in advance of the Meeting.
  - (c) The Secretary will notify such proposed changes to Units in time for delegates to obtain their Units' views before leaving for the Meeting.

## Functions of Executive Committee

- 18. (a) Perform such functions as are alloted to it annually by the General Meeting.
  - (b) Take such action regarding new business as cannot wait until the next General Meeting as they may see fit.
  - (c) Report to General Meeting on all actions taken.
  - (d) Meet as required by the President of the Association or if he is not available, by order of the Vice-President. The convening Officer may obtain decisions by a written vote.
  - (e) A quorum will consist of six members but must have representatives of at least three commands.
  - (f) In the event of no members of the Executive Committee from a Command or Area being available and the representatives from the Command or Area concerned does not consider the views of the Command or Area can be expressed in writing or by proxy he may delegate an officer not below the rank of Major to attend and vote for the Command or Area.
  - (g) The Presiding Officer will have a "Casting Vote".

#### Minutes of Meeting

- 19. (a) Extracts of the Minutes of all General Meetings will be published in the Annual Report.
  - (b) Any action authorized by the Executive Committee will be published in the Annual Report.

#### Secretary, Duties of

20. It shall be the duty of the Secretary to attend all Meetings of the Association and of the Executive Committee; to keep minutes of the transactions at such Meetings in books provided by the Association and to be kept by him for that purpose; to conduct the correspondence, and give all notices required by the rules or by Order of the Association, or the Executive Committee, as the case may be, or the presiding officers thereof, to prepare all reports of the prize lists, and certify and submit the same to the proper meetings and officers of the Association; and to keep all records thereof. He shall be responsible for notifying

all Units and members of amount of dues. To discharge such other duties as may be required from time to time by the Annual General Meeting, the Executive Committee, or by the President. The remuneration of the Secretary shall be fixed by the General Meeting from time to time. He will not be eligible to vote at a General or Executive Meeting.

## **Treasurer**, Duties of

21. The Treasurer shall deposit to the credit of the Association, in a Bank named by a General Meeting, all sums of money paid over to him on behalf of the Association. The payment of all monies for current expenses will be in accordance with the instructions of General Meetings or authority of the Executive Committee. Payments to be made by cheque drawn by the Treasurer, and countersigned by the President of the Association, a member of the Executive Committee, or a member of the Association nominated by them and not below the rank of Major. The remuneration of the Treasurer shall be fixed by the General Meeting from time to time. He will not be entitled to a vote at a General or Executive Meeting.

The Treasurer shall prepare annually his accounts up to the end of the Association year, and submit the same with all proper vouchers, to the auditor of the Association for his audit and at such other times as may be directed by the Executive Committee. The auditor's report and statement will be presented to the next General Meeting. He will not be eligible to vote at a General or Executive Meeting.

## Auditing of Accounts

22. Accounts will be audited annually.

A Chartered Accountant, International Accountant, or other qualified Accountant will be appointed annually by the General Meeting to audit the accounts of the Association. The date of closing the accounts for audit will be decided by the Executive Committee. The audit will be presented to the next General Meeting.

### **Travelling Expenses**

- 23. Rates and numbers to whom issued will depend on funds available.
  - (a) Rates will be decided at each Annual General Meeting for attendance at General and Executive Meetings.
  - (b) The total number whose expenses will be paid for attendance at the next General Meeting will be decided at each General Meeting under the following factors:
    - (i) Expenses will be paid to all members of Executive Committee, attending, in accordance with (a) above.
    - (ii) If representatives from all Units cannot be paid, allotment to Commands will be in proportion to number of Units in each Command, and Members of Executive on strength of Units will be considered as representatives of their own Units and count as part of the Command allotment.

(c) All members attending meetings of the Executive Committee will have their expenses paid in accordance with (a) above. If from lack of funds the General Meeting should limit the funds for travelling, the Executive Committee may at their pleasure restrict the allowable expense to each member or limit the number attending in accordance with the subjects to be discussed.

## **Order of Business**

- 24. The following order of business will be observed at the Annual General Meeting:
  - (a) Presentation of Reports.
  - (b) General Business.
  - (c) Election of Officers.
  - (d) New Business.

The outgoing president, or the officer presiding at the Meeting, will preside at the Annual Dinner.

## **Cancellation of Membership**

25. The membership of any member or the affiliation of any Unit may be cancelled by a three-fifth's vote at a General Meeting. Before a vote is taken the person or unit concerned must be given an opportunity to present his rebuttal in writing and may, if they so desire, address the meeting in person. In case of HQ or Unit the address will be limited to the CO or one person nominated by him.
